For and in consideration of the mutual promises contained herein and in the Lease and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed as follows:

- 1. Guarantor's Representations, Guarantor represents that Guarantor: is parent, legal guardian, related or otherwise has an interest and has elected to execute this Guaranty. Guarantor further represents (i) that they have reviewed the Lease and any addenda thereto or other documents to the extent the guarantor deems appropriate and they understand that the owner's desire to enter into the Lease agreement with Resident is expressly made conditional upon Guarantor's execution of this Guaranty; and (ii) that all information submitted in Rental Application is true and complete and authorized the verification of same performance of a credit check on the Guarantor by any means. Guarantor acknowledges that false information contained in Rental Application may constitute grounds for rejection of Rental Application, Termination of Applicants rights of occupancy and non-return of deposit.
- 2. Guarantee of Obligations, Guarantor hereby individually and unconditionally Guarantees to the owner the full, punctual and complete performance by resident of all obligations of Resident to Owner while resident resides at the community identified above including but not limited to, extensions or renewals of the lease, any transfer to any other unit in the community or when any rent or other charges are increased in accordance with or after the stated term of initial lease. Guarantor agrees to be personally bound by and personally liable for all obligations of resident as if Guarantor executed the lease and all other documents. of providing the Guarantor notice. Guarantor expressly waives the right to receive any such notice from owner. Owner may elect to furnish notice of default and or delinquencies by resident at the address of the Guarantor.
